

Wahkiakum PUD is helping its customers reduce their monthly electric bills and make their workplace more comfortable through its lighting program. Under the Non-Residential Lighting Rebate Program Wahkiakum PUD may be able to pay a portion of the cost to retrofit existing lighting in Wahkiakum County.



PROGRAM GUIDELINES

Customer eligibility:

- **Pre-approval is required for all utility rebate programs prior to installation** and expires sixty (60) days after approval – projects that require longer than sixty days to complete must obtain special approval from Wahkiakum PUD.
- Must be a current commercial, industrial or agricultural electric customer of Wahkiakum PUD.
- Customer must participate in onsite inspection(s) and documentation requirements as required by utility to verify eligibility and installation of materials/equipment.
- Funds for this program are limited. This program is offered on a first-come, first-served basis and is effective until funding is expended or the program ends. Wahkiakum PUD reserves the right to deny an application, modify or discontinue this program without prior notice at the PUD's sole discretion and reserves the right to determine eligibility and the right to verify equipment and materials installed. Incomplete projects may not qualify for rebates.

Pre-condition characteristics of conditioned space:

- Must be used primarily for non-residential purposes.
- Must have a minimum of one year of active, electric services (new construction is not eligible).

Post-condition qualifying contractor and equipment selection:

- Customer may opt to self-install or select a contractor licensed, insured and bonded to work in Washington State; visit [WA State Department of Labor & Industries](https://www.wa.gov/departments/labor-industries) or contact Wahkiakum PUD to confirm contractor eligibility.
- Customers must capture project data in the current Online Lighting Calculator and submit it to Wahkiakum PUD for review and approval; the lighting calculator tool will capture project data reports, projected energy savings, reimbursement levels and eligible equipment specifications. Email Wahkiakum PUD at cs@wahkiakumpud.org to request access to the Online Lighting Calculator and get assigned a username and password.
- Projects reporting a Luminaire Level Lighting Control measure have the following additional requirements:
 - The control product must be listed on the Design Lights Consortium Networked Lighting Control Qualified Products List (<https://designlights.org/qpl/>) as meeting Technical Requirements for NLC5.0 or later, and
 - The control product model number must be included in the "Notes" section of each Measure within the lighting calculator.
- Project must achieve at least a 10 percent kWh reduction (savings requirement varies by measure). For calculated measures, the minimum payment to the end-user is \$5 per measure, and the fully adjusted savings, as determined by the lighting calculator, must be at least 10 percent per measure.
- Customer is responsible for checking with and fulfilling any state, county, city government and/or homeowner's association codes, ordinances, local conditions, restrictions, rules and regulations and obtaining any required building permits when installing measures.

REBATE RATES

Rebate amount cannot exceed 70% of the total cost of the project. Projects saving 200,000 kWh or more, as determined by the lighting calculator, may, at the District's discretion be converted to a 100 percent calculated incentive.

- Project energy savings, reimbursement levels and equipment specifications are found within the lighting calculator spreadsheets, and the spreadsheets capture the completed information during the invoicing process. Incentive rates vary.

DOCUMENTATION CHECKLIST

Prior to Installation

To receive pre-approval, submit the following documentation to Wahkiakum PUD before installation of equipment:

1. Wahkiakum PUD's Non-Residential Lighting Rebate Pre-Qualification Request Form
2. Wahkiakum PUD Online Lighting Calculator (contact Wahkiakum PUD to request access to the calculator and get assigned a username and password). Wahkiakum PUD can assist with this.
3. Provide Wahkiakum PUD the spec sheets for all proposed new lighting
4. Participate in onsite pre-inspection as required by utility to verify eligibility

After Installation

The following documentation must be provided to Wahkiakum PUD within 14 days of installation:

1. Request final onsite post-inspection from Wahkiakum PUD to verify compliance guidelines
2. Equipment/contractor invoice showing:
 - a. physical address of installation
 - b. order or purchase date
 - c. measure requirements have been met (i.e. manufacturer, model number, type and quantity of equipment or product installed/used)
 - d. size
 - e. quantity of equipment installed
 - f. total cost (including installation)
3. Verification installation has cleared all required building and/or electrical permits
